A lot was accomplished and reached back then. Knowledge, key contacts and connections were also established during these foundation years, all while: up. on. ‘The. Hill!’

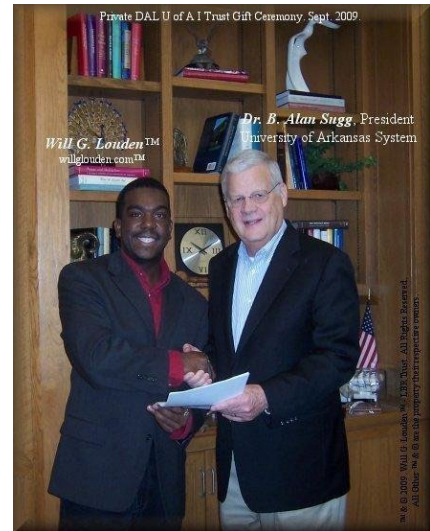
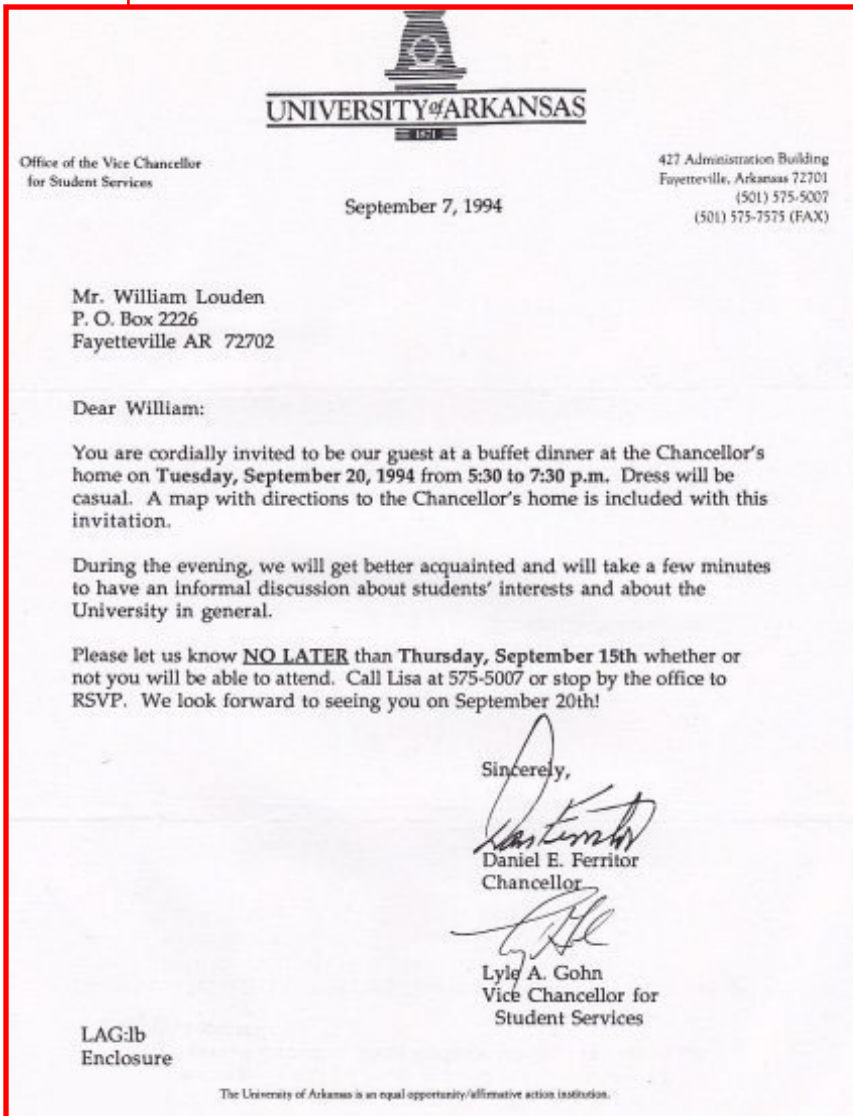

Little did the world know that on Dec. 18, 1939, in a small town in Louisiana (Natchitoches Parish), a visionary and great

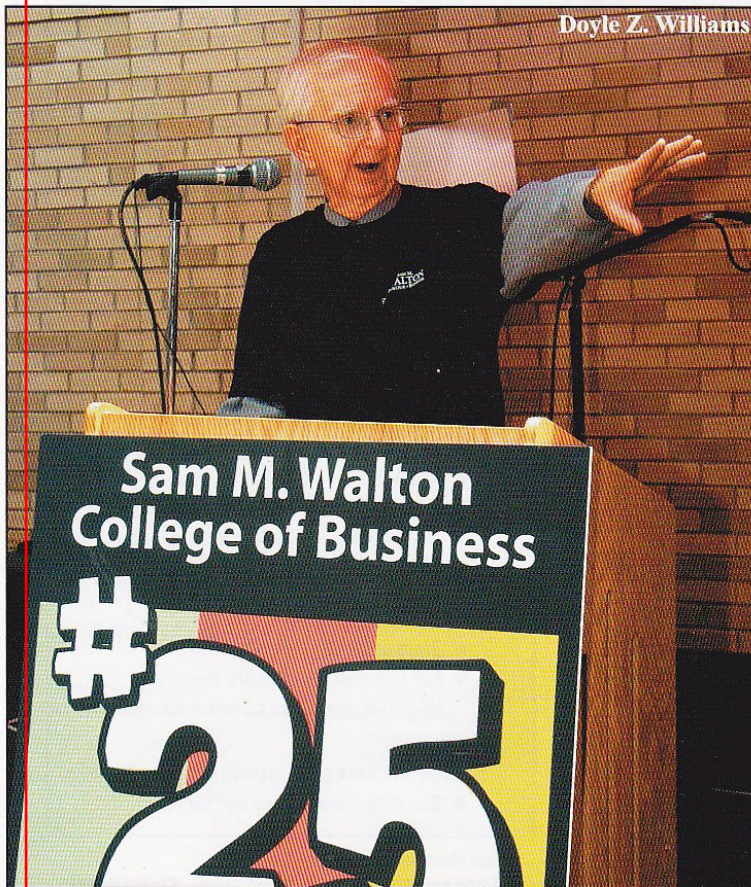

The Road To Deanship and What Makes The Man

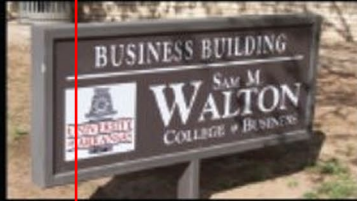
In an article, entitled “Fire, flood, ‘49 Ford shaped Williams’ life,” by Bill Bowden, published Feb. 4, 2002, in the Northwest Arkansas Business Journal, Dean Williams describes in vivid detail the early conditions of his childhood and what some would consider an extreme exercise in adversity. Dean Williams tells how the family home burned to the ground Christmas night in 1943, and having to move into “an abandoned sharecropper’s house on the bayou.” The article also notes how Dean Williams was able to pick his weight in cotton in the 9th grade, “Ninety-nine pounds of cotton in a single day.” He also recounts his first experience with a shower after entering Northwestern State University in 1957. This is not exactly the life one would expect such a seasoned and accomplished leader to ascend from, albeit humble beginnings nonetheless.

The seeds of change are in motion by and through the vision, mission and drive of what I will call the “Dean Factor.” According to an article entitled “The Quiet Storm,” by Alex Daniels of the Arkansas Democrat Gazette, published Oct. 20, 2002, Dean Williams is the human fuel that the academic engine of change burns throughout the Sam M. Walton College of Business at the University of Arkansas at Fayetteville. The “Dean Factor” accelerates the agenda for the next generation of business graduates. In the article, Dr. Karen Pincus, Walton College of Business Accounting Department Chairperson, articulates how the Dean was quick to adapt the accounting curriculum in 1995 to new state CPA examination standards. She said, “In an academic environment, that’s unusual.” Well, unusual he is as well as very effective!
